

Rockbridge County High School Athletic Hall of Fame Criteria

1. The Rockbridge County High School Athletic Hall of Fame Committee will consider nominees who meet the following considerations:
 - The nominee has distinguished themselves and received recognition for their outstanding participation and performance in their respective sport(s).
 - The nominee possessed exemplary character, behavior, and leadership as a student-athlete at Rockbridge County High School and was a positive representative of the school community.
 - The nominee continued after graduation from Rockbridge County High School to participate in athletics and distinguished themselves with outstanding careers at the collegiate level.
 - The nominee, in their post-graduate years, will demonstrate high standards of moral character and integrity and be well respected in the communities where they currently reside and live.
2. The Hall of Fame will recognize any athlete, coach, administrator, or contributor who set themselves apart through outstanding play or service to the athletic department.
 - **Athletes:** student-athletes must be a graduate from Rockbridge County High School and made a positive impact and contribution to the athletic department and school community. The nominee will be chosen based upon their athletic achievement, leadership, character, integrity, and sportsmanship while they were a student-athlete. Athletes are eligible after a minimum of seven (7) years after graduation from Rockbridge County High School.
 - **Coaches:** coaches may be chosen based on their success, knowledge, and contributions made to the athletic department of Rockbridge County High School. They must have shown exemplary moral character and integrity and been a positive example of leadership and sportsmanship. Coaches who are nominees must have promoted educational values to their student-athletes, including encouraging higher education opportunities after high school. Coaches are eligible at any time after being nominated.
 - **Administrators:** administrators may be chosen based on their leadership and contributions made to the athletic department at Rockbridge County High School. The nominee must have shown exemplary moral character and integrity and been a model of sportsmanship for the entire school community. Administrators who are nominees must promote educational values as well as grow all aspects of the athletic department, including the teams, coaches, and student-athletes. Administrators are eligible at any time after being nominated.
 - **Contributors:** Nominees for this category may be chosen for their outstanding dedication, service, and overall contributions to the Rockbridge County High

School Athletic Department. Contributors are eligible at any time after being nominated.

3. There will be a Google Form that is open to the public to nominate student-athletes, coaches, administrators, and contributors into the Hall of Fame.
4. The Rockbridge County Hall of Fame will have a maximum of nine (9) inductees the first year, with a maximum of five (5) inductees per year every year after that.
5. All nominations will remain active and be kept on file for five (5) years after an individual has been nominated.
6. The Rockbridge County High School Hall of Fame Committee will be made up of the following individuals: Principal, Athletic Director, five (5) at-large members, and research specialist. The at-large panel will be appointed by the building principal and athletic director.
 - The Hall of Fame Committee will be responsible for creating and maintaining the hall of fame.
 - The Hall of Fame Committee will be in charge of the selection process.
