This chart shares general guidelines that school administrators will use in an attempt to maintain consistency in applying consequences to similar discipline infractions. Depending upon the individual circumstances of any disciplinary situation, principals may use their administrative judgement in applying consequences outside of these guidelines should it be warranted. Principal discretion will be used to determine which discipline offenses will be recorded in the Student Information System (SIS) following SBAR guidelines. Student behavior histories and infraction severity will be used to guide SBAR decisions. Notes: (1) Fourth and successive offenses in the same category may result in progressively increased disciplinary action. (2) The school has tried to anticipate possible offenses, not every possible act of misconduct may be listed here. Failure to specify a behavior, as an offense does not mean the behavior is acceptable and free from disciplinary actions. (3) Any student suspended from any RCPS school is also suspended from any other school division program. Suspension from another program constitutes suspension from the home school. (4) A student suspended from school may not participate in any school activity from the time of suspension until reinstatement in school. (5) Educational modules may be requried for any of the above offenses.
