BUSINESS ITEMS

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Brooks, seconded by Trustee Lovell, and passed by a 4-0 vote, the Board approved debt service payments in the amount of \$2,381,228.96 due July 15, 2017 to US Bank for Rockbridge County Public School VPSA bonds.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Brooks, seconded by Truste Lovell, and passed by a 4-0 vote the Board approved payment of bills and budget amendments in the amount of \$66,335.64.

- Trustee Brooks stated that he had questioned, and received an explanation earlier in the week, on one amount which was Interactive Health Technologies.
- Matthew Crossman responded that the project initiated by the MRMS PE teachers which will be used for the health aspect during the PE class but also for the math class and the STEM classes at MRMS will use the data for statistical purposes; truly a cross-curriculum project. The project involves 150 fitness wristbands needed each class period for a six period day. The funding came from the Rockbridge County Public Schools Foundation, RCPS, CTE through the Perkins Grant, and the MRMS 21st Century Learning program. There is funding for the program to be on-going.
 - o Trustee Brooks noted that the one of the expense comes out of the RCPS budget, as reimbursement comes from the Foundation.
 - o Vice-Chairman Lewis stated that the concept was originated with the Central Elementary School PE teachers with positive learning from the project.

• Trustee Brooks stated that the board members do contact the Superintendent and Central Office staff if there are questions on the expenditures and do not just automatically approve consent agendas.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Lovell, seconded by Trustee Brooks, and passed by a 4-0 vote, the Board approved the carry over grant appropriation to Fund 50, Title I 2016, in the amount of \$134,287.00

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Brooks, seconded by Trustee Lovell, and passed by a 4-0 vote, the Board approved the carry over grant appropriation to Fund 50, Title II 2016, in the amount of \$89,368.00.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Lovell, seconded by Trustee Brooks, and passed by a 4-0 vote, the Board approved the carry over grant appropriation to Fund 50, VIB IDEA 611 2016, in the amount of \$522,906.00.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Brooks, seconded by Trustee Lovell, and passed by a 4-0 vote, the Board approved the carry over grant appropriation to Fund 50, VIB 619 2016, in the amount of \$1,324.00.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Lovell, seconded by Trustee Strong, and passed by a 4-0 vote, the Board approved the carry over grant appropriation to Fund 50, 21st Century MRMS 2016, in the amount of \$87,157.00.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Brooks, seconded by Trustee Lovell, and passed by a 4-0 vote, the Board approved the carry over grant appropriation to Fund 50, Civics 2017, in the amount of \$19,053.00.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Lovell, seconded by Trustee Strong, and passed by a 4-0 vote, the Board approved the new grant appropriation to Fund 50, RACE to GED 2017, in the amount of \$16,000.00.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Lovell, seconded by Trustee Brooks, and passed by a 4-0 vote, the Board approved the new grant appropriation to Fund 50, GAE 2017, in the amount of \$8,256.00.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Lovell, seconded by Trustee Brooks, and passed by a 4-0 vote, the Board approved the new grant appropriation to Fund 50, AFELA 2017, in the amount of \$76,721.00.

- Vic-Chairman Lewis clarified that the items approved were not part of the aspirational funding and represent another source of revenue.
 - o Mr. Crossman verified that these are specialized programs of which we would not be able to provide services out of the regular operating budget stating that funding is sought by writing grants which requires a lot of reporting.
 - Trustee Brooks requested that with MUNIS software capabilities, line items that are grant expenditures be noted as such.
 - Mr. Crossman stated that it will be noted in future presentations.

BUDGET PLANNING: No discussion

COMMITTEE REPORTS:

Trustee Brooks stated that he will be meeting with the VSBA staff on July 12, 2017 in regards to the Legislative Review Plan for the year which will include discussion of upcoming mandates.

INSTRUCTIONAL REPORT: None

INFORMATIONAL ITEMS:

Dr. Thompson presented information on the VSBA Media Honor Roll. If there are nominations, action will need to take place at the August 2017 meeting of the Rockbridge County School Board.

PUBLIC COMMENT: None

ACTION ITEMS:

Upon recommendation by Vice-Chairman Lewis, and passed by a 4-0 roll call vote, the Board approved Phillip J. Thompson, Agent; Haywood M. Hand, and David S. Daniels, Deputy Agents, to examine and approve the payment of claims, warrants, vouchers, or payrolls on behalf of the Rockbridge County School Board in accordance with Article 6, Section 22.1-122 of the Code of Virginia; warrants shall be signed by such Agent or Deputy Agent and countersigned by the Clerk of the School Board, payable to person or persons firm or corporation entitled to receive such payments.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Brooks, seconded by Trustee Lovell, and passed by a 4-0 vote, the Board appointed Haywood Hand as Deputy Clerk for the calendar year 2017.

Upon recommendation by Vice-Chairman Lewis, motion by Trustee Brooks, seconded by Trustee Lovell, and passed by a 4-0 vote, the Board appointed Haywood Hand as Superintendent Designee for the calendar year 2017.

NEW BUSINESS:

Trustee Brooks asked for clarification of timeline for the Energy Performance Contracting as he interpreted that a decision needs to be made in August and he wants to ensure that the Board of Supervisors make their decision in time to allow the contact to be signed in time.

- Vice-Chairman Lewis stated that the Rockbridge County Board of Supervisors are aware of the deadline and that the Rockbridge County School Board has done all they can at this point. He also stated that the Ad Hoc Committee has met to share information on the Performance Contracting.
- Superintendent Thompson stated that the Rockbridge County Board of Supervisors are
 meeting with the Lexington City Council on July 13, 2017 and will receive a presentation
 from TRANE at that time. If the Rockbridge County Board of Supervisors approve the
 funding, the Performance Contracting project can move forward. He did note that the
 Central Elementary School and Fairfield Elementary School figures are not included in the
 data to be presented to the Lexington City Council.

Trustee Brooks requested that the Comprehensive Plan be placed on the agenda for the Rockbridge County School Board meeting of August 8, 2017.

Trustee Brooks stated that in reviewing Consent Agenda Items, he feels that fund raising requests need to be reviewed closer with set limits put in place.

- Superintendent Thompson stated that this was discussed at the recently held Administrative Retreat relative to being reasonable and to give consideration to families. He stated his perspective that fund raising is a necessary evil to degree noting that it is better when the funds are going to a specific project or trip with the funds going in and out to serve the students of Rockbridge County, as opposed to a fund raiser with funds put into an account for future use in a year or two.
- Trustee Brooks stated that he feels there is a significant amount of families with low income who cannot afford to buy into fund raisers.
 - o Trustee Strong stated that she feels the elementary level is the hardest and is in favor of the sponsored meals at restaurants as opposed to buying items that will not be used.
 - O Superintendent Thompson stated that with some fund raisers at the elementary school level, there are incentive programs for the students to sell item, even if they do not benefit directly from the raised funds, there are is a personal reward. He stated that he will continue to monitor fund raising requests and to ensure that administration remains cognizant in their understanding of what needs to be done.
- Trustee Lovell stated her congratulations to the Mountain View Elementary School Parent Teacher Association and their yearly plan reflecting that they have great parents and teachers involved in support of the students.
- Vice-Chairman Lewis stated that he feels there are two issues in regards to field trips:
 - 1) He feels there is equity in all the schools doing the same field trips, in the same grade;
 - 2) He stated that his hope that students are enabled to have as many as they can siting that they are educational as well.
- Trustee Brooks stated that he feels there may be a need to review policy on field trips and to possibly increase the funding limit on field trips.
- Superintendent Thompson reiterated that this issue has been discussed at the recently held administrative retreat.
