

The Discipline Committee of the Rockbridge County School Board held a special meeting on Wednesday, December 12, 2018 at the Rockbridge County School Board Office.

Present: Trustees Corey Berkstresser, Heather Hostetter, and Wendy Lovell; Haywood Hand, Assistant Superintendent.

CALL TO ORDER:

Trustee Lovell called the meeting to order at 4:00 p.m.

Under Section 2.2-3711.A (2) of the State Code, Trustee Hostetter recommended that the Board go into a *Closed Meeting* to discuss one student discipline matter. Motion was made by Trustee Hostetter, seconded by Trustee Berkstresser, and passed by 3-0 vote.

The Board entered into the *Closed Meeting* at 4:03 p.m.

The Board returned to open session at 5:13 p.m.

Trustee Lovell read the following motion to Certify the Closed Meeting:

WHEREAS, the Rockbridge County School Board has convened a closed meeting on this date pursuant to an affirmative recorded vote and in accordance with the provisions of the Virginia Freedom of Information Act; and

Upon initial motion of Certification of Closed Meeting by Trustee Lovell, and seconded by Trustee Berkstresser, the motion passed by the following roll call vote:



Trustee Berkstresser - Aye


